Objectives and activities					
Charitable purposes	Our objects, as recorded in our constitution are:				
	a. To relieve the needs of children, living in Scotland, who have suffered physical and or mental injuries due to burns or scalds and whose families have suffered as result of burns or scalds, particularly but not exclusively by the provision of recreation and leisure activities. Particular attention will be given to those with major disfigurement, disability or poor social circumstances who have less opportunity to develop through normal childhood.				
	b. The achievement of education of the public relating to fire safety, home safety and burn/ scald first aid at schools, youth groups and/ or local community events.				
Summary of the main activities in relation to these objects	 Summer Camp - August 2016 This years' Summer Camp was held once again held at the Actual Reality Centre at Ardentinny, near Dunoon, 1st to 5th August 2016. As in 205 we discussed with the Actual Reality Management Team the needs of the children to ensure for a successful camp. This year we had the continued challenge in supporting a child with spina bifida, having a nurse as one of the volunteers once again was a necessity. The largest challenge facing the team was having the ability to cope with a wheelchair bound child. Most of the activities provided by the centre are inclusive of wheelchair bound students, therefore the child was able to participate along with the other children. The 2016 Camp was attended by fourteen under 18 year olds supported by seven adult volunteer child care/befrienders, one of the volunteers was a burn survivor who attended camp as a child. This proved hugely successful in that the young children attending for the first time got to meet a 'young adult' who had been a member of the charity and had attended camp as a child themselves. This was our 15th successive SBCC Summer Camp. This year, as last year an invitation was sent out to the British Burns Association, Special Interest Group for Paediatric Burns of Frenchay After Burns [FAB] Club and the Burned Children's Club, Bristol. Unfortunately no children were able to attend. The Summer Camp is the main objective for the charity and the primarily aim is to encourage every child, despite their level of disfigurement/ disability, to try and rebuild confidence, in taking on the challenges that each activity faced them, thus increasing their levels of self-esteem, even if they did not fully complete the challenges.				

Summary of the main activities in relation to these objects continued

We organised two 'offsite' activities in this year's Camp programme, namely one nights swimming at the local swimming pool, booked for our exclusive use and a visit was organised to a session booked on Loch Lomond for wakeboarding and banana boat in doughnut riding on the Loch. Both these activities were fully inclusive for all children.

In the past the children that were 18 or over, had the opportunity to become a Young Volunteer for the SBCC. This was an opportunity for these young adults to support the charity at events and also return to camp as a young volunteer being mentored by an adult volunteer. However, having spoken to other 'burn children charities' we have now reviewed the policy and the members agreed that the a short time away/ break from the charity is better practice, to encourage the child to have 'life experiences' with the opportunity to contact and re-join from the age of 21 years as a Young Adult Volunteer.

Once again we invited children who were just under camp age, to come along to the open day and meet some of the other children and volunteers. They also had the opportunity to try out some of the activities. This year three of the child came along with a parent. The feedback was positive from both the child and their parent and the feeling was that 'they wished they could have stayed for longer and the children are looking forward to coming along to camp in 2017 once they were old enough'.

We continue to invite guests from sponsors, supporters and the Scottish Fire Service along on the Wednesday, this is an opportunity for them to see what their fundraising and support has provided for the children and also to take part in the activities with the children. The Open Day has become a great success over the years as we find that the children with their newly regained confidence can deliver their own support to the guests during the activities, thus proving that the development of confidence and self-esteem objectives have been met in line with our mission statement.

Volunteer Management

Supported by the charity, two of the volunteers, Mark Stevenson and Claire Gardiner attended a workshop in Glasgow, to develop their volunteer management skills and continue to develop a Handbook for any Young Adult Volunteers who wish to join and support the charity in the future.

Summary of the main activities in relation to these objects continued

National Jamboree Burns Weekend Camp

We would like to thank the Children's' Burn Trust for the invitation to attend the Jamboree in October 2016.

It is an opportunity for the children to be brought together to forget their everyday pressures of growing up in their home or school environment to have fun. It is also an ideal opportunity for the younger children who are apprehensive about being away from their family to join children from around the UK for this three day event.

It was very unfortunate that none of the children from the SBCC were able to attend due to the SBCC not having the chaperones to escort for the weekend.

Family Events

Our main goal each year is to arrange the Summer Camp, as well as a Family Day out event and if the funds are available host at least one Families Weekend. Since the Summer Camp is only open to the 8 to 18 year olds the Family Events are also important, they are an ideal opportunity for not only the children of all ages to meet, but for the parents to meet others in similar situation and share experiences, realising that they are not alone.

Family Event: Blair Drummond Safari Park: 18 June 2016

Suggested by the children, we organised another day out at Blair Drummond Safari Park. A total of 75 family members and 2 volunteers attended [16 club members with their families]. Transport was provided for those who needed it. Once again this type of event gives the opportunity to a number of families who had not previously attended any SBCC event to meet other families. It also gave some families who had met at previous events to renew friendships. A lot of experiences were discussed between the families and once again a piece of feedback they now realised that they were not alone on facing the challenges of bringing up a burn survivor child.

Family 'Therapeutic' Weekend – December 2015

We held another Families Weekend in December 2015. Once again the primary aim of the weekend is to pull together a number of key benefits to support the burn-injured children and their families.

The main objective of the weekend is to enable families of burn injured children to meet one another and share their experiences, within an informal therapeutic programme and help the children who have been burned, and their families, to feel less isolated. In addition, because the focus is on the family unit as opposed to the burn injured child alone, it is hoped that the family will feel more supported and be able to develop important coping strategies for life after a burn.

Summary of the main activities in relation to these objects continued

Nine families to the weekend, held once again at Netherurd House, a facility in Peeblesshire which was exclusively booked for our organisation. Transport to/ from the centre was arranged for the families who were unable to make their own way there. The weekend involved the meeting and greeting of the new families who had not been to any club function previously and give the families the opportunity to relax away from their normal everyday environment. On the Saturday morning a visit from the World of Wings Birds of Prey was arranged and in the afternoon everyone went along to the Pantomime in Edinburgh, this once again proved highly successful and enjoyed by both the children and adults. On the Saturday evening we organised a Christmas Party and magic show. We also arranged for a 'surprise' visit from 'Santa Claus' to pass on an early Christmas present to all the children, the children loved this.

Three of the volunteers Claire, Gail and Amy completed their Level 2 Food & Hygiene training which enabled the charity to provide self-catering at the centre. This saved on average £2000, which is a substantial saving, thus freeing funds to be focussed on providing more event support in the future.

On the Sunday a discussion group/ forum was organised to help the parents; to openly discuss their experiences with each other and was chaired by Mark Stevenson, chairman of the SBCC.

Once again, feedback from the weekend was extremely positive from both parents and children, so much so the committee have discussed and agreed the need for these occurring on an annual basis, should funding allow.

Our policy is to maintain reserves to meet our commitment to arrange each year a Summer Camp, a Families, a minimum of one 'all' Family Day Event and a Families Weekend, if funds are available.

Families 'Activity' Weekend: 29th April – 2nd May 2016 Up until now the Families weekend have been held at the Girl Guide centre at Netherurd House, Blythe Bridge, Peeblesshire, following a great deal of discussion the trustees committee decided to organise a family 'adventure' weekend, based on the children's Summer Camp.

The number of families that can attend Netherurd House is limited, by holding at Ardentinny gave 14 families from all over Scotland the opportunity to come together and do the outdoor pursuits normally that only the Summer Camp attendees get to try.

This adventure weekend gave the whole family as a unit to develop coaching and team skills during the outdoor activities such as canoeing, rock hopping, archery, sailing and crate building. The weekend involved the families being residential and it of course offered the families some great opportunities to get to know each other as well as share their vast experiences.

Summary of the main activities in relation to these objects Continued

Even though the weekend was more expensive in comparison to the weekend at Netherurd, this activity weekend gave more families the opportunity to attend and take part in more activities. It was also an ideal opportunity for the children under eight to see what summer camp is all about and hopefully be less apprehensive about being away from their family possibly for the first time.

The organising of more activity weekends of this type will be dependent on the funds available, it is the intention to look into grant funding as a possible option.

Family support following bereavement

Shortly after our successful family's weekend, one of the families contacted the Charity to inform us that one of our young registered members had lost their mother to a sudden death. The family were very popular at the family weekend and the volunteers and families felt for the loss of the very popular young Mum. As a result, the club member aged 9 and her young sister, aged 2 are being cared for now by their Grandmother.

The Trustees agreed that in the interest of the family it would be good for the children and their Grandmother to have a break away from their normal environment. It was discussed and agreed that the charity cover the cost for a week-long holiday at a caravan park on the East Coast of Scotland.

The family were very grateful and took the opportunity to try and bring some semblance of normality back into their lives. The family continue with their contact with the Club and regularly attend our events.

Family Liaison Officer

As a mother of a young burn survivor child, Amy McCabe took on this role in 2014 and continues to act as the Family Liaison for the charity. As a parent who has had to cope with her child's unfortunate accident, she is very aware of the trauma that the whole family, including the child, go through and is able, through personal experience, to relate to the concerns of the other parents and siblings.

Parents have commented on how beneficial the role has been. They feel less isolated knowing that they can talk to someone & share experiences with a parent who has had to cope with their child's accident. Being able to talk to someone, especially just after the accident has relived some of the worry, stress and anxiety.

Amy is also the coordinator for the family forum site on Facebook; the forum it is only open to the parents. Due to families living all over Scotland, it continues to be a useful social media site tool where the parents can keep in touch and ask each other questions.

Summary of the main activities in relation to these objects continued

Safety Promotion & Education

Thermostatic Mixing Valves (TMV's)

With the successful passage to legislation of PE786 – Dealing with Thermostatic Mixing Valves (TMV's), the Scottish Building Standards in Scotland changed on the 1st May 2006. All new build and refurbishment private and public properties must now be fitted with a type 2 (TMV2 scheme approved) thermostatic mixing valve to the bath hot-water outlet to prevent the incidence of scalding water.

Through Open Days and presentations we continue to promote the hazards of hot water and the importance of the legislation. We thank Horne Engineering for the continued technical support.

Hair Straightener & Hot Water Safety Campaigns

A national poster & leaflet campaign has been successfully maintained annually since the award of a £5000 grant in 2009 from the Electrical Safety Council.

As part of the Child Accident Prevention Trust [CAPT] children safety weeks in June and November, the SBCC continues to provide literature on request to NHS Hospitals and childcare centres in England, Wales & Scotland.

Through Open Days and presentations we continue to raise awareness of the dangers associated with hair straighteners.

Fire Work Safety Awareness Campaign

During the RoSPA Seminar In 2013 the SBCC launched a new Firework Safety Awareness poster and leaflet campaign. This campaign was set up following a request by the McCabe Family whose son suffered a serious firework injury in 2010.

Ben had said to his Mum that he wanted to raise awareness amongst other children the dangers associated with fireworks. The SBCC worked with Ben's Family and produced a series of leaflets and posters including a picture of Ben with his injuries showing, as the lead image, to display what happens when a child is accidentally struck by a rocket type firework at an organised display. This was a new project for the SBCC as we had never been asked to utilise a 'live' case study in any previous campaign.

Amy continues to work with the Scottish Police and Fire Service and in November during a visit to his school by local firefighters Ben gave a talk his peers.

Summary of the main activities in relation to these objects continued

Open Days

The charity continues to be involved with the Scottish Fire Service Stations and when the opportunity arises attend Open Days. This gives the SBCC the opportunity to primarily promote safety in the home and promote the work of the charity.

Website

The charity website continues to play an important part in promoting the work of the charity (<u>www.theburnsclub.org.uk</u>). The charity website is now is now maintained by one of the charity trustees – Agnes Stevenson.

Until the closure of the FRSB in 2016 the Scottish Burned Children's Club were a member. Additional information:

2015/ 2016 - The SBCC remains a relatively 'small' charity and cannot predict or guarantee income each year. The treasurer does monitor the financial situation and the trustees are kept informed, the volunteers do endeavor to organise and support as many activities as possible during the year. The overall unrestricted expenditure for 2015/ 6 did increase by £10815.88 and with the decrease of income of £17580.22 in comparison to 2014/5 this did mean a deficit of £15007.54. We do have to bear in mind that the charity in 2014/5 did receive two large donations of £7,878.02 & £9,500 respectively.

- With a few exceptions the majority of the expenditure did remain average in comparison to previous years however some factors should be taken in to account
- The mobile phone expenditure did increase, but this was expected due to the Family Liaison role. This has continued to prove to be an important resource. As a mother of a young burn survivor child, as a parent who has had to cope with her child's unfortunate accident, she is very aware of the trauma that the whole family, including the child, go through and is able, through personal experience, to relate to the concerns of the other parents and siblings. Parents have commented on how beneficial the role has been. They feel less isolated knowing that they can talk to someone & share experiences with a parent who has had to cope with their child's accident. Being able to talk to someone, especially just after the accident has relived some of the worry, stress and anxiety.

The majority of the referrals come from the staff at the Glasgow sick kids hospital and when a family decides to register their child with the charity, the Family Liaison is an important resource in making contact with the child's parent/ guardian to introduce herself, welcome the family and explain the work of the charity

- Unfortunately two arranged family events were cancelled due to too few numbers wishing to attend. As for all events the cost of transport is expensive and the overall cost per head attending would not have been financially viable. Since the charity supports children throughout Scotland, on average two coaches have to be arranged for each event, on average the cost of the transport is £700 for each event. However the charity did hold a trip to Blair Drummond Safari Park.
- The decision was made to cancel the Family weekend in December 2016 and hold our first Family Activity weekend in May 2016. The weekend cost was £11,514.35, this did have an impact on the expenditure for 2015/ 2016. But by holding the weekend at Ardentinny, same location/ centre of the summer camp it was an opportunity for more families to attend, be able to take part in activities and also see where the children attend in the summer. It was also an opportunity to introduce the venue to the children not eligible or camp yet. The deposit for the December Families weekend at Netherurd House was reimbursed [£2,000].
- As mentioned in 2014/2015, the development of the charity website has now been completed. The site is maintained by one of the volunteers, to save on costs. This is recognised as a vital resource for informing the public, businesses and potential fundraisers and grant funders of the work of the charity and a means of keeping the family members informed of planned activities.

- Due to the age of the charity vehicle it was decided that it was not financially viable to cover the costs of the repairs needed, which would have outreached the actually value of the vehicle. The chairperson offered to use his personal vehicle to cover charity events and since able to tow the trailer, essential for taking equipment to summer camp, this has proven to be cost saving. It is estimated that this will reduce the charities expenditure by on average £1,500 per year.
- The current IT lease agreement ended in October 2016, it was discussed and agreed by the committee to purchase the leased PC and laptop for use by the Treasurer, Secretary and Chairperson and renew the lease for an IPad. Since the launch of the charity the trustees have used person equipment and the access to the internet is covered by the trustees, it was felt that the investment was needed to support the administration of the charities activities
- Over the years children from the charity have benefited from another charity 'Katie's Ski tracks' and at no cost to the SBCC a child has had the opportunity to go on a skiing holiday with other children. It was discussed and agreed that the SBCC would make a donation of £500, to support the continual work of this charity, who had experienced financial uncertainty. www.katiesskitracks.org Registered charity: 1130907.

2014/2015 – This year the charity was fortunate to receive a substantial donation from Signature aviation and be chosen as the nominated charity at the HR Network Awards in Glasgow. The SBCC remains a 'small' charity and cannot predict or guarantee income each year. The treasurer does monitor the financial situation and the trustees are kept informed, the volunteers do endeavor to organise and support as many activities as possible during the year. The overall unrestricted expenditure for 2014/2015 did decrease by £6713 and taking in to account the unrestricted income of £42571 for the period this did mean an overall surplus of £13389. With a few exceptions the majority of the expenditure did remain average in comparison to previous years however the factors should be taken in to account:

- The mobile phone expenditure did increase, but this was expected due to the introduction of the Family Liaison role. This has proved to be an important resource. As a mother of a young burn survivor child, Amy McCabe took on this role in 2014. As a parent who has had to cope with her child's unfortunate accident, she is very aware of the trauma that the whole family, including the child, go through and is able, through personal experience, to relate to the concerns of the other parents and siblings. Parents have commented on how beneficial the role has been. They feel less isolated knowing that they can talk to someone & share experiences with a parent who has had to cope with their child's accident. Being able to talk to someone, especially just after the accident has relived some of the worry, stress and anxiety.
- Unfortunately one of the family events was cancelled by the centre, however the charity did arrange a trip to Edinburgh Zoo. As for all events the cost of transport is expensive. Since the charity supports children throughout Scotland, on average two coaches have to be arranged for each event and on average the cost of the transport is on average £700 for each event.
- The cost of promotional materials slightly increased, as replenishment of stock was not needed. If funds are available the charity does hope to have the opportunity to update the pull up banners in 2016.

- The development of the charity website has now been completed. The site is maintained by one of the volunteers, to save on costs.
- It was discussed and agreed by the committee to lease a PC and laptop for use by the Treasurer, Secretary and Chairperson. Since the launch of the charity the trustees have used person equipment and the access to the internet is covered by the trustees, it was felt that the investment was needed to support the administration of the charities activities. The lease is due to expire in October 2016 and will be reviewed before any contract is renewed.
- The increase expenditure in support of Fundraising did increase, however since the fundraising ball was cancelled the deposit for the venue was reimbursed. [Misc income £1500].
- The cost for the Young Adult burn survivor volunteers was initially covered by the SBCC, but the overall costs were reimbursed. [Misc income £1005.15].

2013/ 2014 – Once again the unrestricted income did fall again in comparison to previous year by £17,470 but the funds available to support the charities aims do remain positive. The SBCC remains a small and cannot predict or guarantee income each year. The treasurer does monitor the financial situation and the trustees are kept informed, the volunteers do endeavor to organise and support as many activities as possible during the year. The overall unrestricted expenditure for 2013/ 2014 did decrease by £10,404, taking in to account the income of £27,102 for the period this did mean an overall deficit of £8793 for the period. With a few exceptions the majority of the expenditure did remain average in comparison to previous years however the factors should be taken in to account:

- In 2014 the Summer Camp was once again held in Scotland. In comparison to 2013, the increased expenditure was needed to
 cover the cost of the additional activities and the increased numbers that attended the camp. £1360 was reimbursed from the
 Frenchay After Burns [FAB] club in Bristol to cover the cost for a group of children from their club to attend.
- Two family events were arranged in 2014, the Summer Party and the trip to M&D's theme park. This increased the expenditure for the period. As for all events the cost of transport is expensive. Since the charity supports children throughout Scotland, on average two coaches have to be arranged for each event and on average the cost of the transport is on average £700 for each event.
- The cost of promotional materials was reduced during this period, as replenishment of stock was not needed. If funds are available the charity does hope to have the opportunity to update the pull up banners in 2015.
- The development of the charity website has now been completed. The site is maintained by one of the volunteers, to save on costs.
- It was discussed and agreed by the committee to lease a PC and laptop for use by the Treasurer, Secretary and Chairperson. Since the launch of the charity the trustees have used person equipment and the access to the internet is covered by the trustees, it was felt that the investment was needed to support the administration of the charities activities. The lease is due to expire in October 2016 and will be reviewed before any contract is renewed.

• The increase expenditure in support of Fundraising did increase, this was due to the cost of £1,075 to enter the Spartan Race Challenge.

2012/2013 – The income did fall in comparison to the previous year by £18, 223.16, but the funds that are available to support the charities aims do remain positive. The SBCC is a small charity and cannot predict or guarantee income each year. The trustees are kept informed of the financial situation and the volunteers do endeavor to organise as many activities as possible during the year. The overall expenditure for 2012/2013 was average in comparison to previous years.

- In 2013 the Summer Camp was held in Scotland, in comparison to 2012 the expenditure was lower, this was because additional activities in the location are limited we were unable to book the squad biking/ Pony trekking as planned. We were also unable to attend National camp in 2013.
- The charity vehicle costs were average in comparison to previous years.
- The majority of the promotional material costs in 2012 were for the posters and leaflets associated with the launch of the Firework Safety Awareness Campaign
- Equipment/ Assets costs did increase, we were able to fund the purchase of waterproof digital cameras for the children to use at camp and at the family events.
- Long overdue was the development of the charity website. After the initial outcome to have the site designed and set up by a company, the site is maintained by one of the volunteers.
- We held a Families Weekend in April of 2013 and have another planned for Early December 2013.
- The storage unit hire costs did increase, due to the volume of assets a larger unit had to be arranged.

2011/2012 – On average the expenditure increased by £11,049. The majority of expenditure remained on par with previous years; however the following factors should be taken into account:

- In 2012 the Summer Camp returned did return to a Scottish location, in comparison to 2011 the costs did increase by £6100. The following should be taken into account; transport costs in 2011 were covered by an Edinburgh Business. Additionally, at the Scottish location additional activity costs have to be taken into account, whereas at the National camp they receive funding/ sponsorship. The SBCC is a Scottish charity, but the trustees are considering attending the National Camp again in the future, as it is a great opportunity
- for the SBCC children to meet other children from throughout England & Wales. There is also the opportunity for children from other burn clubs to attend the SBCC camp in Scotland.
- The charity vehicle costs did increase to cover repair costs and replacement tyres.
